Sturgeon Fin Clip Sampling

- ☐ Any report of Atlantic Sturgeon observations must indicate condition and whether or not a fin clip for genetic sampling was able to be collected.

Vessel Strike of Protected Marine Species ***Report Immediately***

- ☐ Report ASAP to Marine Mammal and Sea Turtle Stranding Hotline (866) 755 – 6622 and U.S. Coast Guard VHF Channel 16.
- ☐ Report to CVOW-C Monitoring and Coordination Center (757) 366 – 7000 or (757) 731 – 8307 (mobile) and Dominion Energy ECC via cvowreporting@dominionenergy.com.
- ☐ **Stop work** if injury or death caused by Project activities until reviewed by NOAA OPR and authorized to return to work by Dominion Energy.

Objects of Potential Cultural Significance / Unanticipated Discoveries

- ☐ Report to Dominion Energy ECC via cvowreporting@dominionenergy.com.
- ☐ Collect photos/videos without disturbing site if possible. **Stop Work may be warranted.** Avoid area and/or potential artifacts until further instruction from Dominion Energy ECC.

Dead or Injured Birds or Bats

- ☐ Collect photographs if possible and report to Dominion Energy ECC via cvowreporting@dominionenergy.com. Please note key information, such as vessel, time, date, GPS location, and concurrent activities.
- ☐ Any dead protected species discovered will need to be preserved on ice for further examination.

Fisheries Concerns (Fish Kills, Ghost Gear, Invasive Fish Species)

- ☐ Report any significant and sudden death of fish (fish kill), any identified ghost gear, and any sightings of Lionfish (invasive species) or Atlantic Sturgeon (ESA-listed species) to the Lead PSO or ECM.
- ☐ Lead PSO/ECM report ASAP to Dominion Energy ECC via cvowreporting@dominionenergy.com.

Oil Spill ***Report Immediately***

- ☐ Report immediately to Qualified Individual/Incident Commander (QI/IC):

- ☐ Report immediately to National Response Center (800) 424 – 8802 or USCG Sector Virginia via VHF Channel 16. If reported to USCG, follow up ASAP with report to National Response Center.

Marine Debris

- ☐ Any debris that is accidentally released into the marine environment must be reported to Dominion Energy ECC via cvowreporting@dominionenergy.com. Await guidance from ECC prior to recovery efforts if marine debris is lost within the boundaries of an archaeological resource or sensitive ecological/ benthic resource area. (“Marine debris” is defined as any object or fragment of wood, metal, glass, rubber, plastic, cloth, paper, or any other man-made item or material that is lost or discarded in the marine environment. Items which are not lost or discarded will not be reported to agencies formally as marine debris unless all attempts at recovery have been unsuccessful.)

Foundation Installation Deviation

- ☐ Any deviation from the CVOWC Construction Mitigation and Monitoring Plan (CMMP) and the appendices within must be reported to Dominion Energy ECC via cvowreporting@dominionenergy.com. Examples are failure to shutdown report in response to PSO/PAM detection, installation without critical installation component (i.e. DBBC), inability to provide clearance, etc. These must be reported within 24-hours and frequently involve sensitive details that warrant review and approval of the CVOWC Project, Environmental (DEV and E&S), and Legal team before submittal.
